Blockchain Gambling



- **Decentralization**

No single entity controls the currency; it is supported by blockchain networks. This provides inherent security benefits.

- **Anonymity**

While not completely anonymous, crypto transactions obfuscate identities better than credit cards or bank transfers.

- **Transparency**

Blockchain ledgers are public, allowing transaction tracing and transparency.

- **Irreversibility**

Crypto transactions cannot be reversed or disputed as with credit card payments.

S8B, Whats behind

Firstly, it is fully legitimate, having passed comprehensive audits, KYCs and being supported by two companies, along with their teams of committed developers, experience, advisors and a fully licensed working casino platform.

Secondly, the incorporation of GambleFi \$S8B into a functional casino gaming product will instantly offer a variety of utilities upon the token's launch, going beyond simple trading. Each utility will uniquely enhance gameplay and offer diverse advantages to token holders. These utilities will deliver passive income for holders as other benefits for registered participants as players at casino or holders thru investments rounds and public token launch at two blockchains, firstly at Ethereum, upon that on Solana.

Moreover, the platform introduces an attractive multiply reward streams:

- 20% Bonus in USDC credits on casino based on invested amount in presale.
- Revenue Dividend Share reward utility is accessible for all S8B stakers. 50% of Net Gaming Revenue, at end of each month will be available for claim all holders in USDC.
- Passive income through a staking contract, where participants will earn rewards by staking their tokens.
- Holders will gain access to featuring perks such as access to the Wheel of Fortune, free \$S8B chips, cashback on losses, and various exclusive bonuses.
- NFTs on Solana will introduce additional utilities and advantages for \$S8B holders, increase trading volume, and attract more players from the rapidly expanding casino community within the Solana network.

🎁 20% BONUS IN USDC CREDITS

Investors participating in the \$S8B fund raising rounds on our platform will receive a 20% back on their investments. This promotion will be credited in USDC and can be used at casino upon TGE. Presale Investors will be credited with casino algorithm upon registration at casino with Metmask and wallet which they used in presale rounds. Please note that these credits cannot be used for Live Dealer games and must be wagered 20 times before they can be withdrawn.

The total amount raised in presales is \$900,000. Investors will receive a 20%, equating to \$180,000 USDC, credited to their registered player accounts at the casino. This bonus will contribute to the Revenue Dividend Share for the initial month. The casino's algorithms will ascertain the Net Gaming Revenue in USDC, just as they do for S8B.

🎮 UNLOCKING VIP SUITS

The launch of token will activate VIP SUITS statuses for all token holders, providing them with special privileges as outlined in the casino's VIP section for a month.

The benefits received by VIP SUITS to token holders, including monthly cashback on losses, free chips, varied limits, and bonus conditions, will depend on the amount of purchased S8B tokens in presale and deposited at casino. These VIP SUITS are valid for a month, after which the statuses will be reset and recalculated based on the amount of S8B deposited in the player's account for the following month.

💰 SINGLE SIDE STAKING AND REVENUE DIVIDEND REWARD SHARE

The staking contract is designed to enable a staking within the S8B888BITS ecosystem where users can stake \$S8B tokens and earn two types of rewards:

\$S8B Token Rewards and Revenue Dividend Reward Share in \$USDC.

Participants in the presale can secure their tokens at presale rates by using a staking dApp at the casino immediately after the Token Generation Event (TGE). They can engage in the staking contract using the same MetaMask accounts they used during the presale.

Staking Token

- The token to be staked is the \$S8B token.
- Users can stake any amount of \$S8B tokens at any time.
- Staked \$S8B tokens are locked for periods of 7, 14, or 30 days.
- The Revenue Dividend Reward Share is available to all S8B staking participants who commit to a locked period of 30 days.
- Rewards are distributed proportionally based on the stake amount.

Supplying Rewards / Revenue Dividend Reward Share

- \$S8B token rewards amount to 14% of the total \$S8B supply. These rewards are distributed among stakers who hold active stake positions, with allocation based on the proportion of their stake amount.
- Additional rewards - are rewards from Revenue Dividend Reward Share. Each month, **50% of the netto casino revenue** will be added to the staking contract in \$USDC.
- Only \$S8B users with a staking lock for 30 days can claim this amount through the dApp on player account at s8b.888bits.com.
- Revenue share in \$USDC will be injected into a staking contract each 30 days from TGE, from operational casino wallets.
- The casino will inject 50% of the total casino netto (deposit - withdrawal) from the operational wallet in \$USDC.
- Unallocated \$S8B rewards remain in the contract if no active staking positions exist.

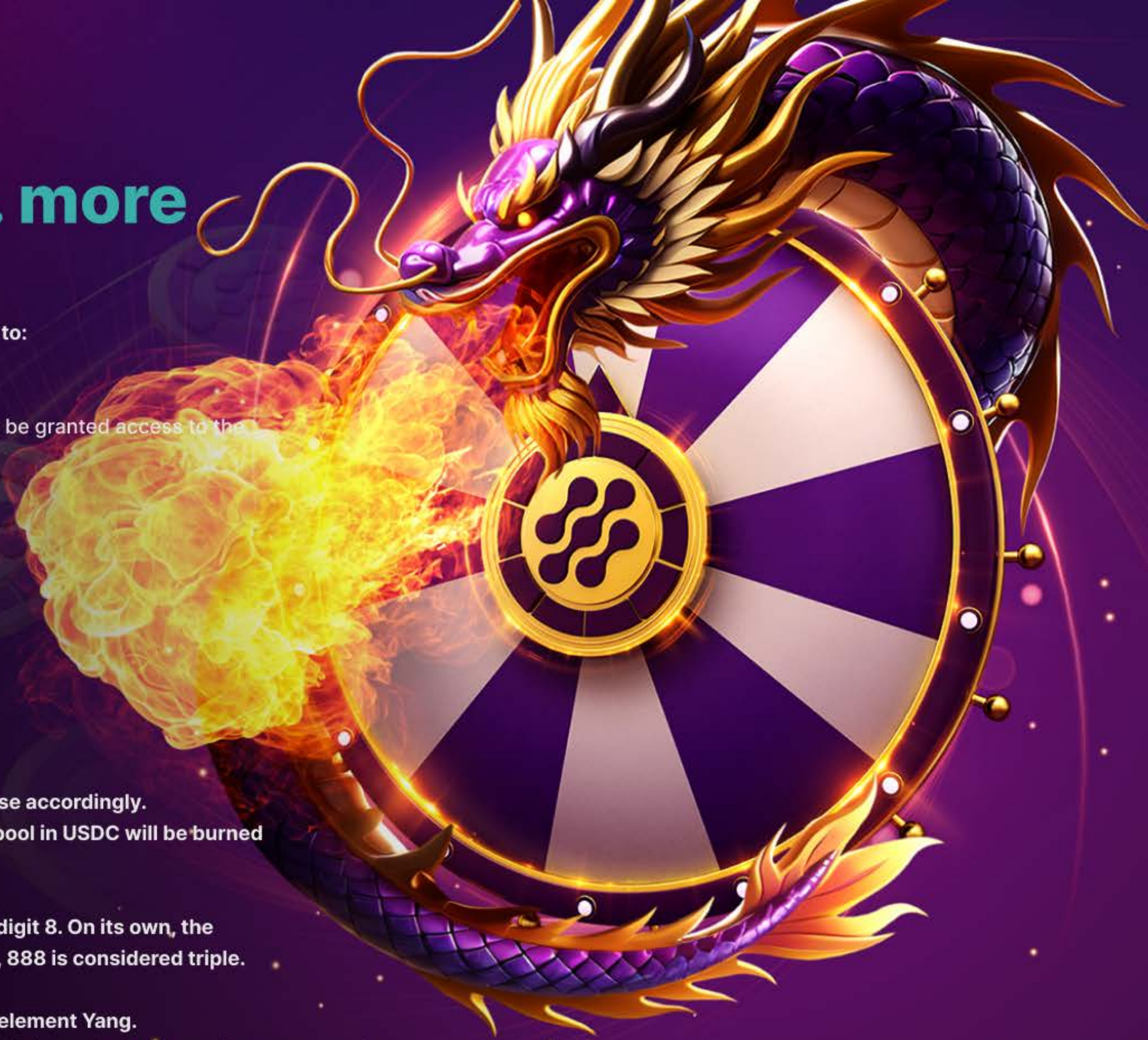
Should holders demonstrate steadfastness in their holdings, the \$8B prize pool will increase accordingly.

This early access allows participants to become involved in a new project at its nascent stage, ahead of the official coin/token launch where the general public can invest. As exclusive means granting early access privileges. Engaging in a pre-sale enables investors to acquire tokens at a preferential 'early-bird' price, prior to their public release.

SEED ROUND

Seed round price: 1 S8B = \$0.0025

This initial phase is designed for early backers who believe in the potential of our project from the outset. Investments made during this round are at the most favorable terms, recognizing the early commitment and trust of our investors.

The seed presale round is allocated 7% of the total token supply, which amounts to 62,222,222.22 \$S8B tokens.

In this round, each wallet is limited to a maximum investment of \$5,555.56, equivalent to 2,222,220.00 \$S8B tokens, representing 0.25% of the total token supply.

STRATEGIC ROUND

Strategic round price: 1 S8B = \$0.00375

In this phase, we welcome investors who bring not only capital but also strategic value to our project.

This round is open to VC funding for those who can offer expertise, or resources that align with our long-term vision.

The strategic presale round is allocated 9% of the total token supply, which amounts to 79,999,999.92 \$S8B tokens, equivalent to 1,333,333.00 \$S8B tokens, representing 0.15% of the total token supply.

In this round, each personal wallet is limited to a maximum investment of \$5,000.00, VC funding on request.

PUBLIC ROUND

Public round price: 1 S8B = \$0.005

The seed presale round is allocated 10% of the total token supply, which amounts to 88,888,888.00 \$S8B tokens.
